1. Current symptoms:

I have hormonal imbalance, chemical sensitivity, sleep disorder, memory problems, join pain, anger problems.

2. Dental history:

I have root canal done some times in 1990s, wisdom tooth removed, three root removed surgery after all the crowns broke off, four amalgam filling also sometime in 1993, I have those four amalgam replaced with composite in Dec. 2009 by a very pro-amalgam dentist, with no protection, because he said it just for the cosmetic reason only. A week ago, I went to different Dentist to have an evaluation and was told that one of the teeth is discolored, he was not sure if there is any mercury left in the teeth.

3. Dental work currently in place:

I am not sure at this moment if I should continue with the chelation protocol or should I look for a Bio- Dentist to replace those fillings again. I have some stain on the teeth that had the amalgam removed, and I am not sure if any Mercury still left inside the teeth.

4. Mother's dentistry:

My Mother did not have any dental work done during pregnancy.

5. Vaccinations:

I came from the foreign country so I don't have the record of vaccinations, we did not have a lot there, I had one flu shot in 1998 and became very sick after that, so I stopped.

I take T3 2mg, 2 times a day, hydrocotisol 5mg, 2times a day, I was taking dmsa, 25mg every 3 hour and ALA100mg, with taurine and biotin. fish oil, flax oil, b complex 100.
