## Health history for hair test 573

### 1) What are your current symptoms and health history?

Answer: Memory issues, teeth grinding, teeth tapping, fertility issues, body pain, headaches, jaw pain, fatigue, cold and heat intolerances, gut and throat burning, chemical sensitive, food intolerances, lethargy, depression, anxious, nervous, stress intolerance, dry eyes, red palms of hands and palms turn blue in the cold, joint pain, don't recover from exercise well, constipation, Fibromyalgia, degenerative disc disease, SI dysfunction, Raynauds syndrome, no sex drive, hormones wont balance even after a year, hard to lose weight, but very easy to put it on.etc.

#### 2) Dental history (wisdom teeth removed? First root canal placed? Braces? First amalgam etc...)

Answer: 33 small amalgams placed at age 9. Four RCT, four wisdom teeth removed, 8 amalgams replaced, two bridges (bio-compatible). I have had a full dental revision on July4th, 2011. All metal and cavitations were done at the time. All replacement materials were biocompatible; used BioComp for testing.

3) What dental work do you currently have in place? What part of the dental cleanup have you completed?

Answer: I have two bridges, 8 amalgams and one front upper partial.,

### 4) What dentistry did your mother have at any time before or during pregnancy?

Answer: I don't know much about my Mom, but I do know she had a full upper denture since age 16 and one all gold tooth. I also think she had a bottom partial.

#### 5) What vaccinations have you had and when (including flu and especially travel shots)?

Answer: All standard childhood, required vaccination, plus Hepatitis B series, several flu shots and two pneumonia shots and four tetanus shots.

6) Supplements and medications (including dosages) taken at time of hair test, or for the 3-6 months before the sample was taken. Answer: 800mg.Vit E, 200mg Selenium, 50mg. Zinc, 800mg. Magnesium Citrate, 5mg. DMSA every four hours for three days on and four off, 1000mg. Vit.C (when my stomach allows it), two caps of Milk Thistle, 1000mg. Cod Liver Oil, PB Probiotics (4),

#### 7) Other information you feel may be relevant?

Answer: Symptoms accumulated from age nine on. I have been told by a Physiatrist that my soft tissues resemble that of someone 30 years older than me.
