• What are your current symptoms and health history? Child age 2, diagnosed with autism. Delay in gross and fine motor skills and language. Poor feeding and weight gain from 2-4 months while breastfed, supplemented with formula from 4 months onward. Child self-weaned from breastmilk at 8 months. Child is second of three children. First child age 5 is NT and third child age 8 months has normal development.

• Dental history (Wisdom teeth removed and when? Any other extractions. First root canal placed? Braces? First amalgam etc...) **None.**

- What dental work do you currently have in place? What part of the dental clean-up have you completed? None.
- What dentistry did your mother have at any time before or during pregnancy? Amalgams present, had dental cleanings while pregnant

• What vaccinations have you had and when (including flu and especially travel shots)? Fully vaccinated and had one flu shot at age 12 months. In addition, mother had vaccination shortly after child's birth for pertussis (while breastfeeding).
