What are your current symptoms and health history?

Currently almost symptom free - occasional headaches, muscle numbness (mostly arms and legs), fatigue, muscle weakness

Prior to having amalgams removed: sub-acute thyroiditis, seizures, insomnia, hot flashes, adrenal exhaustion, anxiety, fear, panic attacks, depression, psychosis, arrythmia, infertility, headaches, dizziness, peripheral neuropathy, disequilibrium, pre-syncope, memory loss, confusion, total hair loss

Dental history (Wisdom teeth removed and when? Any other extractions. First root canal placed? Braces? First amalgam etc...)

Root canaled - tooth extracted 1 April 2013 along with two amalgams. Tooth with root canal was also packed with amalgam. All amalgams and root canal put in place in Feb/March/April 2011. Braces in early teens for 2-3 years.

What dental work do you currently have in place? What part of the dental clean-up have you completed?

Currently have 1 crown in place - potentially an amalgam under crown. Other clean up (amalgam removal, root canaled tooth extraction) done April 2013.

What dentistry did your mother have at any time before or during pregnancy?

Many, many, many amalgams prior to pregnancy.

What vaccinations have you had and when (including flu and especially travel shots)?

Flu shot for last 3 years (mandatory as I am a hospital worker); MMS, etc years and years ago

Supplements and medications (including dosages) taken at time of hair test, or for the 3-6 months before the sample was taken?

Apple cider vinegar 1T pd, Probiotics - 50 billion CFU pd, Biotin - 10K mcb pd, digestive enzymes, zinc - 30 mg, magnesium - 450 mg, cod liver oil 1T pd, bee pollen 1t pd, B50
